POST TITLE: International Consultant to Final Evaluation of UNDP's Being LGBTI in Asia and the Pacific project (BLIAP)

1) GENERAL BACKGROUND

Lesbian, gay, bisexual, transgender and intersex (LGBTI) people represent some of the most marginalized populations in Asia and the Pacific. Ignorance, intolerance, and hatred based on prejudices continue to result in social exclusion and fuel violations of the rights of LGBTI people, including intolerable levels of violence.

Many LGBTI people experience poverty and social disadvantage due to the intersection of social and economic factors such as family rejection and restricted education and employment opportunities due to discrimination. Given that it is conservatively estimated that there are at least 100 million LGBTI people living in Asia and the Pacific,¹ attention to the needs and human rights of LGBTI people is essential if countries are to achieve the Sustainable Development Goals (SDGs), a key feature of which is the underlying principle and commitment to 'leave no one behind'

1.2 Project description

Phase 1 of Being LGBTI in Asia and the Pacific (BLIAP), initiated in 2012, focused on developing an evidence base of the lived experiences of LGBTI people through research and the engagement of civil society groups throughout the region. This engagement was facilitated through convening eight national LGBTI dialogues, publishing <u>national reports</u> and producing 12 videos highlighting community stories from the region. Informed by this process, a second phase of the project was designed to strengthen the capacity of civil society groups, government departments and human rights bodies to effectively address priority issues relating to sexual orientation, gender identity and expression and sex characteristics (SOGIESC), build broad coalitions with key stakeholders, including the private sector, media and academic institutions, and strengthen the evidence base on SOGIE and intersex issues through a combination of regional and country specific programming.

As recommended in the 2018 Programme Review, an updated five-year strategy was developed in consultation with a wide range of partners at national and regional levels, including civil society and government representatives. The current strategy of the project builds upon the foundation laid over five years (2014-2018) of implementation that developed a solid foundation of evidence, fostered broad multisectoral partnerships and undertaken a substantive body of work to promote LGBTI inclusive development in Asia. It focuses on further utilization of the evidence base developed and taking next steps in the substantive body of work in progress across a range of areas to achieve dividends in the form of an increased number of LGBTI inclusive protective laws, policies and programs.

BLIAP serves as a platform to engage and leverage mandates of partners such as governments, civil society, national human rights institutions, the private sector, academic institutions, donors, foundations and UN agencies to address inequality, violence and discrimination on the basis of SOGIESC, and promote universal access to health and social services. Through national, regional and global consultations with community representatives and experts, five key areas of inclusion have been identified as priority areas for action. The **goal** of the project is to promote LGBTI inclusion in Asia Pacific across these five development dimensions.

- 1: Legal reform and political and civic participation
- 2: Access to justice, personal security and anti-violence
- 3: Health
- 4: Economic well-being
- 5: Education

The end-of-project outcome is:

LGBTI social and economic inclusion in Asia Pacific advanced through promulgation and implementation of protective laws, policies and programmes which mitigate discrimination and violence, ensure access to LGBTI appropriate services.

The design of BLIAP reflects key elements of the action-oriented enablers underpinning UNDP's regional work:

- Advancing rights and inclusion of marginalized groups and communities through advocacy and targeted interventions;
- Deepening south south cooperation and sharing of lessons, expertise and knowledge;
- Building partnerships across the development spectrum, and connecting diverse public and private sector partners through regional networks and convening multi-country forums;
- Partnering and joint programming with other UN agencies and sub-regional institutions;
- Conducting context specific analyses of existing and emerging regional issues; and
- Boosting and scaling up innovative practices, including through inter-regional collaboration and partnerships.

A project review was conducted in 2018. The project was also included in the end-term gender review of the UNDP Asia-Pacific regional programme 2014-2017. The formal mid-term review of the

project was carried out as part of the Mid-Term Review (MTR) of the UNDP Asia-Pacific Regional Programme Document (RPD) in November 2020²

2) OBJECTIVES OF THE ASSIGNMENT

The main purpose of the final evaluation is to provide evidence-based information to guide future programming on LGBTI inclusion and rights, consolidate lessons learned and capture good practices, and provide forward-looking recommendations for continued improvement of programming by UNDP and partners.

At its inception, BLIAP was the first dedicated LGBTI inclusion project by UNDP, and it has since inspired similar regional projects in other regions. During its eight years of implementation the project concept has evolved significantly to respond to new evidence, strategic opportunities, political sensitivities, changes in financial resource availability, and other changes in internal and external operating environment including the

COVID-19 pandemic context. The evaluation will concentrate on impact and outcome level results and evaluate the success of the groundbreaking flagship project in reaching its stated goals, how it has been able to adapt to new circumstances, and what have been the key factors that have enabled successes, and/or held the project back from achieving its full potential.

3) SCOPE OF WORK

The evaluation will cover project activities and results at regional level and at country level in selected countries where the project has had significant engagement (China, India, Laos, Pakistan, Thailand, and Vietnam). The final evaluation will assess the project's progress against expected outcomes and impact as captured in the project theory of change (ToC) and the results and resources framework (RRF). The evaluation will build on the findings of the 2018 project review, as well as the Mid-Term Review of the Regional Programme Document of UNDP Asia-Pacific (2020), and will focus on achievements during the RPD 2018-2021.

The key objectives of the final evaluation are to

- Assess the project's unique value proposition and sources of comparative advantage relative to other initiatives, including UNDP's unique value added
- Assess to what extent the project has facilitated LGBTI inclusion in the region
- Assess the performance of the project in terms of achieving its intended outputs and the contribution of the outputs to outcomes as according to project's theory of change
- Identify any unintended outcomes, positive or negative, that were not foreseen in the theory of change
- Identify challenges and factors that have affected the achievement of project results and assess the
 effectiveness of the approaches that the project has adopted to address these challenges
- Identify key enablers and factors that have been critical to the project's success
- Assess the project's alignment with UNDP's RPD, UNDP Strategic Plan, and the UNDP HIV and Health Strategy and its contribution to the leave no-one behind (LNOB) agenda
- Identify lessons learned and provide concrete and forward-looking recommendations to inform future LGBTI inclusion and rights programming in the region
