ANNEX I

TERMS OF REFERENCE

1. BACKGROUND

DEEP-Women Entrepreneurs (DEEP - WE) is a project financed by the Swedish International Development Cooperation Agency (SIDA) under the productive families Economic Empowerment Programme (DEEP), which was launched on January 2013 and is executed by the united Nations Development Programme in the Palestinian Territories (UNDP/ PAPP). DEEP - WE promotes inclusive economic growth; it is a specialized economic empowerment program to help graduate productive low-income women from poverty and dependence on aid to economic self-reliance. The DEEP modality provides a solid and inclusive approach for targeting vulnerable, yet productive, households and engaging their members in sustainable income generating activities, mainly micro and small enterprise development, to provide employment and bridge their consumption poverty gap.

Since 2013 UNDP work within the DEEP-WE supported by Swedish International Development Agency (SIDA) highlighted the need to focus on women's economic empowerment due to persisting local practices, policies and laws that are affecting or diminishing women's employability leading to inadequate fulfilment of women's human rights and gender equality.

More specifically, DEEP – WE aims to assist low-income women and their households to graduate from poverty through establishing income generation projects. The project will work on identifying relevant and feasible activities to be implemented with women through qualified and experienced NGOs, business development service providers, and microfinance institutions. The project adopts a participatory methodology in the design of income generating interventions that builds on and develops the exiting capitals that define the household's livelihoods. Through this methodology, the project ensures that the targeted women are actively engaged in the process of the design and implementation, thereby ensuring a strong sense of ownership among them, which is a guarantee of the sustainability of the intervention.

DEEP - WE will provide business development services and coaching to 772 entrepreneurs including training and on site consultancy, it will offer solidarity financing to 772 entrepreneurs to assist in the procurement of the goods, works or services as necessary inputs for their economic projects. Moreover, this programme is promoting women's economic empowerment in Area C, East Jerusalem and Gaza.

As per the project agreement between Sweden, represented by The Swedish International Development Cooperation Agency (SIDA) and The United Nations Development Programme (UNDP); an independent mid-term review of DEEP WE's performance shall be carried out after 18 months of implementation.

UNDP is seeking to recruit a consultant to carry out the mid-term review evaluation, to be based in West Bank, but is able to carry out all the expected activities in West Bank, Gaza Strip and East Jerusalem.

The Evaluation Consultant should be ready to work in Gaza Strip. If movement constraints, do not allow for this possibility, the consultant should utilise any available resources for conducting reliable data gathering based on tools developed by the consultant.

2. OBJECTIVES OF THE ASSIGNMENT:

The Mid-Term Review (MTR) will assess the progress of the project against stated outputs as of November 2014, as well as identify issues and recommend course corrections. It will also highlight issues and challenges affecting effective and efficient implementation of outputs and their contribution to project outcomes and impact and recommend whether results obtained thus far warrant an extension of the project.

The specific objectives of the MTR are:

- 1. Assessment of the project's progress towards promoting increased rate of economically active women in WB area C, GS and East Jerusalem practicing their economic rights.
- 2. The main weaknesses in programme implementation in order to resolve the issues related to them and improve the programme's performance in the future stage.
- 3. The activities that contributed the most to the achievement on the objectives and those which were the least successful in this.
- 4. The obstacles and challenges that faced the programme and how they were overcome.
- 5. Lessons learned till today.
- 6. Assessment of the project's contribution to the capacity of key service delivery institutions/NGOs; including the partner Micro Finance Institutions, in implementing policies at the local level that promote and protect women's human rights to access employment and social protection.

3. SCOPE OF WORK:

- The relevance of the Business Development Services Packages with the needs of the poor & vulnerable women entrepreneurs.

- Assessment of the efficiency with which project outputs are being achieved

Effectiveness
