Evaluation recommendation 1. To expand its funding base in response to development needs, UNDP should look to new partnerships and alternative financial sources.

Management response: UNDP Kosovo is actively exploring opportunities for new strategic partnerships and alternative financing by engaging with IFIs, the EU, Kosovo Institutions, the private sector, and diaspora. In its capacity as technical lead for the UN Kosovo Team's (UNKT) Socio-Economic Response Plan to COVID-19 and based on UNDP's Programmatic Offers, the CO will deploy leading international expertise both to support its efforts in enriching the government's economic recovery programme with particular emphasis on green recovery, digitization, and social protection, and will seek to partner with IFIs, private sector and other development partners in mobilizing alternative financing.

Evaluation recommendation 2. UNDP should continue to emphasize gender equality and women's empowerment and strive to integrate more gender-sensitive activities across its portfolio of projects.

Management response: UNDP Kosovo will continue to promote women's political and economic empowerment, and mainstream gender in a balanced manner throughout its programme. In addition, UNDP Kosovo will ensure that projects and programmes are designed in a gender sensitive manner and include gender disaggregated indicators and targets. Initiatives such as empowering young women who aspire politics, with support of experienced women politicians as

their mentors over the last year was one of the most effective leadership and innovative interventions. Specific attention as we go forward will be given to women economic empowerment, access to social and legal services in our efforts to Building Back Better and response to COVID19 impact.

Evaluation recommendation 3. UNDP should continue its efforts to enhance governance at central and local levels, through anti-corruption policies, safety and security, and increased attention to other important rule of law issues. UNDP should consider mobilizing advice and expertise to help develop policy frameworks in other rule of law areas, for instance addressing the informal economy, money laundering, terrorist financing and economic crime.

Management response: UNDP Kosovo is well placed to deliver results against this specific recommendation, having just embarked on the 3<sup>rd</sup> phase of Support Ani-Corruption Efforts project that among others addresses issues of money laundry, asset confiscation and repatriation of stolen assets. The CO will also continue to support the security sector in the area of cyber security, small arms and explosives control, community engagement in the design and implementation of prevention of violent extremism (PVE) programmes and set up of a referral mechanism for prevention of PVE.

Evaluation recommendation 4. While continuing its current support frame for employment institutions, UNDP should consider complementary interventions in the field of vocational education and training and adult education to improve the effectiveness of employment policies. Over the long term, responsibility for implementing employment policies should transfer to national authorities, allowing UNDP to focus more on strategic aspects and design and evaluation activities

Management response: The office initiated discussions with the Ministry of Labour and Social Welfare regarding the diversification of employment programmes and vocational education in line with development trends in the region and labour market needs. On the latter, UNDP will continue to provide support to the ministry with a market needs assessment to identify skills gaps and potential for more strategic employment programmes. Expert advice will be provided to policymakers to enhance strategic planning. In the meantime, the office will facilitate the work of the public employment service, especially at municipal level, for more effective and efficient service delivery until full implementation of existing financing agreements between UNDP Kosovo and the Ministry of Labour and Social Welfare. UNDP will play its convening role in bringing together key stakeholders from the private sector, educational institutions and employment authorities to facilitate joint planning for training that will allow for the development of future skills.

**Management response**: UNDP will continue its implementation of Active Labour Market Programmes and aims to expand the programme to engage particularly with the youth in all sectors through self-employment and through targeted wage subsidy programme, especially in response to COVID-19.

Evaluation recommendation 6. UNDP should promote integrated measures combining education, employment and social welfare to fight poverty and social exclusion, with emphasis on women and youth.

Management response: The CO will support development of digital solutions for addressing the skills gaps, with focus on the future skills required in the labour market. That will also be part of the package of self-employment and wage subsidy programmes. In parallel, the CO will support addressing issues aiming to improve key governance aspects, in coordination closely with the central government, municipalities and Centers for Social Welfare (CSW). In doing so, it will upgrade the existing monitoring system into an innovative one for effective targeting and provision of the right level of support in a gender equitable manner for vulnerable groups and individuals and those harder to reach. The ultimate aim is to strengthen coordination and communication between line ministries and Local level – Municipalities and CSWs for improved quality of social service delivery and reporting against service delivery standards.

Evaluation recommendation 7. UNDP has an important role to play in Kosovo in strengthening administrative capacity for environmental policy implementation and disaster risk reduction at central and local level, but this will require much more substantial funding than at p resent.

Management response: Due to Kosovo's status, it is not eligible to funding from the global environmental vertical funds (e.g. GEF, GCF). This is well noted in the evaluation report. The CO is actively developing a plan – which entails advancing the European Green Deal, utilise UNDPs Climate Promise and embark into dialogue with development partners for potential partnerships towards Build Back Greener in response to COVID-19. UNDP will continue to support the government's efforts to step up climate action and strengthen disaster risk reduction efforts, and will actively explore new strategic partnerships and financing.

**Management response**: UNDP Kosovo has developed its Results and Resource Framework (RRF) for CDP 2021-2025. Based on the initial recommendations by the IEO, it paid specific attention to include well-defined and measurable indicators and targets in the RRF reflecting an adequate balance between programme portfolios and realistic targets based on foreseen size of the programme over the next 5 years.
