RE: Missing management response to the terminal evaluation for the project "Programme National de volontariat en Mauritanie (PNVM)".

This note has been prepared with reference to the terminal evaluation for the project "Programme National de volontariat en Mauritanie" (PNVM). The referenced evaluation was completed in December 2017. It appears that the team responsible at the time for managing the programme, did not duly file a management response upon receipt of the final evaluation report. The evaluation therefore is still outstanding in the UNDP Evaluation Resource Centre database.

Noting that there have been several changes of team both in UNDP CO and UNV and that the relevant project managers have since left the organization with consequent loss of institutional memory, the UNV Regional Office for West and Central Africa (ROWCA) is not in a position to complete and file such management response post-facto. Nevertheless, the attached table (Annex I) provides the elements of a management response to address key recommendations identified in the evaluation.

Based on consultation with the Evaluation Focal Point in UNV HQ, this note is to record that UNV ROWCA is aware of the missing management response. This note and its Annex serves in lieu of the management response for the purpose of closing the outstanding evaluation in the UNDP Evaluation Resource Centre.
