Management Response:				
Risk management and sustainability planning are key components of the FWFA Project. Anticipatory and adaptive management planning and strategies will be embedded in the new project design. While the recommendation to link DevLIVE to Ambisyon 2040 outcomes is laudable, this is too Ambitious for the project to implement at this point. UNDP will continue to promote the use of DevLIVE to ensure citizen's participation and feedback in large-scale government projects.
