Overall comments: The CO finds the evaluation results and conclusions informative in assessing the degree to which the project met its intended outcomes and results. The report notes that the project was essentially an 'equip and train' project. The evaluation noted the relevance and coherence of the project, while acknowledging that a number of factors directly affected project. The evaluation reports that the project has been completed but not without significant challenges. The challenges faced by the project team to deliver the project overlapped and were unparalleled in recent times for project delivery. The challenges related to the restrictions imposed by the widespread outbreak of COVID, elevated levels of insecurity and direct attacks on the electoral process, persistent political disputes between Federal Government of Somalia (FGS) and Federal Member States (FMS) leadership and within the FGS leadership which at times resulted in violence, continual delays with the electoral process, supply chain delays, and the switch from good oversight of elections security by appointed National Elections Security Task Force (NESTF) to poor oversight by the subsequently appointed National Elections Security Committee (NESC). These were often desperate times and the challenges were huge and required innovative ways to deliver the equipment and the training ahead of the ever-changing elections dates. These challenges all affected project delivery and continuity, and so the progress and results of this project should be viewed against the backdrop of these significant difficulties. The evaluation report notes that JOC is a new capability for the Somali police and represents a big step towards modernization. It acknowledges that JOC staff will require further training and development after the elections to realize the potential that the JOCs offer. IESG has already proposed donor support for ongoing support through the Joint Police Program (JPP). FBA funded and led the WSD training which was attended by WSD staff from every JOC. FBA intends to continue to support the training and development of WSD staff starting with Puntland where the JOCs are fully operational and the WSDs have been active. The evaluation report notes that development of the WSDs added value to the project with the FBA situating its assistance within its larger engagement on women and security. The project evaluation provides key lessons about successful implementation approaches and operational practices for similar 'equip and train' projects. The report provides the IESG and the wider UN teams-(I thought "I" denotes integration, why the separation) an opportunity to learn from themselves and their partners. The proposed actionable recommendations, which have been accepted, provide guidance for future programming and highlights some considerations for ownership of future similar projects. The implementation of the recommendations will be considered alongside the lessons that will be provided by a separate lessons learned activity.

Evaluation Recommendation or Issue 1:	Maintain IESG efforts to find post-project support for the operationalization of the JOCs with the Joint Police Programme (JPP) or other relevant security sector initiative. That program should ensure continued support for the state police that want to carry on with their JOCs, such as Puntland and Galmudug, so they can be operational for their state elections. This assistance should continue through the next elections due in 2026 with UNPOL support and guidance.			
Management Response:	Accepted. The project was designed for the JOCs to remain as an enduring and value-added capability for Somali police beyond the elections. The Joint Police Program is well placed to continue to support to sustain the JOCs.

Evaluation Recommendation or Issue 2:	For the next electoral cycle, IESG should focus on the more programmatic elements of elections security, such as elections integrity and strengthening the NIEC for its role in ensuring elections security, and the prevention of violence during the process, including issues of VAWE. IESG should also contribute to the inclusive electoral process perspective to the human rights/elections components in security sector personnel trainings for the 2026 process and provide election-specific expertise for the UN for elections security.			
Management Response:	Accepted. This will be emphasized with the NIEC regarding elements of elections security, such as elections integrity and strengthening the NIEC for its role in ensuring elections security. The protection of women is not peculiar to the elections as it is an enduring endeavor within Somalia that the UN mission is well seized of and advocates strongly for. This is also addressed by recommendation 3.

Evaluation Recommendation or Issue 3:	IESG should continue its close collaboration with UNPOL for any future elections security support endeavors. UNPOL is an essential actor with its NESC membership, UN Police advisors in the field, membership in the Joint Police Programme and close collaboration with federal/state police forces and AMISOM Police. The UN should provide a part-time UNPOL Advisor for IESG.			
Management Response:	Accepted. Elections security is a very specialized field of endeavor best led by the security experts to allow IESG to focus on the technical aspects of the electoral process. The UN Police Unit within UNSOM is well placed to assume a role for elections security and advice to Somali authorities, as it did when the NESC replaced the NESTF, and to coordinate the UN mission's participation and contribution to elections security. IESG will seek an UNPOL staff member to advise IESG and the wider UN mission on elections security matters. This can be a part time role 4-2 years out from the next elections but a more dedicated staff resource will be required 2 years out. UNPOL field officers too should be prepared to advise on elections security for FMS level elections.

Evaluation Recommendation or Issue 4:	All UN support for elections security should start well in advance of the 2026 elections so that mechanisms, such as the JOCs or national coordination bodies, can be well established and operational before voter registration and the start of the electoral campaign and remain active through the announcement of the results and inauguration of the newly elected officials. This is especially important if these elections are to be universal suffrage.			
Management Response:	Accepted. The very same point was one of the major recommendations from the 2016-17 elections security lessons learned report. It is expected to be a key lesson from 2021-22 elections security lessons learned workshop.

Evaluation Recommendation or Issue 5:	IESG and other UN efforts working on these issues in the future should take advantage of the field level coverage provided by the UN field offices and regional security advisers and integrate their support into the design of election security support activities. Include the gender advisors at field level in the efforts involved with addressing VAWE and women's electoral participation.			
Management Response:	Partially Accepted. IESG made best possible of use of UN police, military and other field officers such as UNSOS for logistics support. AMISOM field officers supported elections security efforts including for this project. The report suggests that the IESG field officers too should be used for elections security. They are not security experts. Moreover, for the 2026 elections in which greater citizen participation is anticipated, IESG field officers are likely to be fully committed to support the electoral process. UNPOL's proposed lead for the UN for elections security will provide for wider use of UN specialist security field officers (police and military) to support elections security efforts in all regions. Note that ATMIS is not expected to have an active role in Somalia by then according to the recent ATMIS mandate.

Management Response:	Accepted. Within the UN mission in Somalia, many parties come together to collaborate and coordinate around an agreed mechanism usually with a TOR. For elections security, existing mechanisms were well used and some new ones set up by the lead Somali security authorities. The latter mechanisms were somewhat ad hoc with no TOR or minutes, notwithstanding the persistent advice provided on the need for them.

This is especially relevant when the national level is not fulfilling its collection and aggregation role, but it should be a basic part of project implementation, management and monitoring.
