#### 1. INTRODUCTION

The LPAC meeting was chaired by Mr. Stephen Rodriques, the UNDP Country Director and Co-chaired by Mr. Gerald Mugabe, representing the Ministry of Finance and Economic Planning, which is the coordinating agency for development cooperation in Rwanda. The UNDP Country Director in his introductory remarks mentioned that the new governance projects are building on achievements from the just concluded governance programmes and are fully aligned with both national, corporate and global frameworks, mainly the United Nations Development Assistance Plan (UNDAP) 2, the UNDP Country Programme Document (CPD), the National Strategy for Transformation (NST I), the Vison 2020, The Vision 2050, the Agenda 2063 and the Sustainable Development Goals. Mr. Gerald Mugabe commended UNDP for the continued partnership and the alignment of UNDP projects to national priorities as well as the high level of participation in the preparation of the programme documents.

The aim of the LPAC is to assess the quality of the proposed projects against national priorities, UNDP's corporate planning framework and quality standards for programming. It gathers the main programme proponents and stakeholders, and presents and scrutinizes the Projects Documents, using a predetermined checklist.

Following the introductory remarks by the Co-chairs, the programme team presented the three governance projects:

- 1. Deepening Democracy through Strengthening Citizen Participation and Accountable Governance (DDAG), 2018-2023
- 2. Strengthening Civil Society Organizations for Responsive and Accountable Governance in Rwanda (CSO), 2018-2023
- 3. Strengthening the Rule of Law in Rwanda: Justice, Peace and Security for the People (A2J), 2018-2023

#### 2. Presentation and Review of the Programme Documents

## 2.1. Presentation of the Projects Documents

After presenting the development challenges that the governance projects will attempt to address in the areas of rule of law, peace and security, citizen participation, media development, services delivery and CSO strengthening, the programme team presented how the 3 programmes are aligned to the NST, the Vision 2030/2050, the Agenda 2063, the SDGs, the UNDAP and the UNDP Country Programme Document (CPD).

The three 5-year governance projecst respond to NST priority areas namely: **Priority area 2:** Ensure Safety and Security of citizens and property, **Priority area 4:** Strengthen Justice, Law and Order, **Priority area 5:** Strengthen Capacity, Service delivery and Accountability of public institutions, and **Priority area 6:** Increase citizens participation and engagement in development. Related interventions will respond to sustainable development goals (SDGs), specifically on SDGs 5, 10 and 16 with an aim to achieve UNDAP **Outcome 5:** "By 2023, people in Rwanda benefit from enhanced gender equality, justice, human rights, peace and security" and **Outcome 6:** "By 2023, people in Rwanda participate more actively in democratic and development processes and benefit from transparent and accountable public and private sector institutions that develop evidence-based policies and deliver quality services".

The DDAG project comprises two main components: Inclusive Participation in Governance and Deepening Accountability and is implemented by 3 implementing partners: NEC, RGB and MHC. MINALOC is a Responsible Party while NFPO, parliament, Media Self-Regulatory Body and media organizations are direct beneficiaries.

The CSO project comprises three main components: Capacity development of CSOs, Voice strengthening (engagement of CSOs in policy dialogue and advocacy) and conducive environment. The programme is implemented by RGB and UNDP. UNDP will particularly manage directly Human Rights and Gender Equality related interventions.

The A2J project comprises four main components: Access to quality justice, Community based crime prevention, Compliance with Human Rights commitment and Societal healing for social cohesion. The programme is implemented by 3 implementing partners: MINIJUST, RNP and NURC. Other stakeholders include Rwanda Bar Association (RBA) and Prisons Fellowship Rwanda (PFR) acting as Responsible Parties.

The proposed projects will be executed through the National Implementation Modality (NIM).

#### 2.2. Programme Budget

The total budget for each project for 5 years was presented as follow:

# 3. Social and Environmental Screening (SES)

After the presentation of the three programme documents, the programme team presented the Social and Environmental Screening (SES) of the programmes. Based on the SES checklist, the following was noted:

- ✓ The 3 programmes integrate overarching principles to strengthen Social and Environmental Sustainability through mainstreaming the human-rights based approach, promoting Gender equality and women's empowerment, and mainstreaming environmental sustainability.
- ✓ There are no major Social and Environmental risks identified linked to the programmes.
- ✓ Any risk associated with the limited knowledge of rightsholders to claim their rights will be addressed through sensitization and capacity building.

The UNDP Country Director appreciated the contribution of the various Implementing Partners and reiterated UNDP's continued commitment to contribute to transformational governance in Rwanda. He called upon implementing partners and stakeholders to provide to the drafting team any further comments on the projects documents within a week to enable finalization of the documents.

The Representative of MINECOFIN thanked UNDP and the drafting teams for the high quality project documents and promised Government counterparts' cooperation in the implementation of the projects.
