Dear Nicholas,

As promised, sharing the final version of the CPD for reference. This version was cleared by MOFCOM in consultation with MOFA and we are awaiting the official endorsement letter, which is expected later this afternoon before proceeding with submission to HQ.

As mentioned the second half of the four rounds of review by Govt focused heavily on the global partnership pillar with observations coming in particular from MFA as well as CIDCA. We have however been able to protect content and entry points to work on the efficiency, transparency, standards, sustainability and climate impact of Chinese development cooperation (and investments) without necessarily using these terms.

On LNOB, we managed to maintain the terminology and references on gender as well as PLHIV but had to concede regrettably on the term "sexual and gender minorities", which we had suggested in lieu of LGBTQI. As you know, this area falls under the UNDP regional programme and as such doesn't affect the integrity of our work although on principled grounds, I was insisting albeit unsuccessfully for the reference to be kept. We understand that the same adjustment had to be made by UNFPA in their CPD.
