BACKGROUND

In 2017, the Government of Jordan established a Prevention/Countering Violent Extremism (P/CVE) Unit to provide specialized diagnosis, resources, and coordinate national programmes related to de radicalization, countering, and preventing violent extremism. The duties of the Unit are to: identify motives and drivers of radicalization; conduct and gather studies and research; build national capacities; establish strategic communications; develop and monitor key performance indicators; and support the efforts of the state in developing strategies to prevent ideological radicalization and extremism. The Unit is seen as a key element of supporting the design and implementation of the governmental National Action Plan (NAP) on PVE and engages with all related actors, including line ministries, governmental agencies, civil society, and the international community.

The Unit is established within the Prime Ministry and works in close liaison with other governmental structures. A key element of the work of the P/CVE Unit will be to undertake effective communications, writing and reporting of P/CVE initiatives implemented in Jordan, and to coordinate with relevant actors to ensure the impact of the work is in line with the National Action Plan in ensuring maximum impact and results against defined quality criteria.

In support of these efforts by the P/CVE Unit and the Government of Jordan, UNDP's Jordan Support to Preventing Violent Extremism in Jordan Project aims to strengthen national efforts at reducing the threat of radicalization and violent extremism. The work of UNDP in this area is delivered through its Governance & Peace Pillar / PVE and Strengthening Social Cohesion



team, supported through funding from the Government of Japan, and which is closely aligned to regional and global activities by UNDP in this field.

PURPOSE OF THE CONSULTANCY

UNDP seeks to contract a Communications, Writing & Reporting Expert to provide relevant technical advice, assistance, and support to the P/CVE Unit in its outreach efforts, peer review for some of the research, and the launching of several critical research, assessments and mappings that are intended to be conducted in partnership with UNDP and other partners over the duration of the contract.

INSTITUTIONAL ARRANGEMENTS

Under the overall contractual supervision of UNDPs Deputy Resident Representative in close coordination with the Senior Programme Specialist, the Communications, Writing & Reporting Expert will work under the management and guidance of, and will also report to, the P/CVE Unit Director and / or the Chief Technical Advisor of the Unit.

- 3. Attend and participate in events planned for (January, February and March 2022), and draft reports based on key findings.
- 4. Peer review of material provided to the Unit, whether in research or background material related to programmes and activities being implemented.
- 5. Provide advice and guidance on drafting the methodology framework and tools for the local assessment of radicalization and tolerance.
- 6. Communications and visibility materials for the Units website.... Etc.
- 7. Other tasks as needed.

- b) Having received the highest score based on the following weight of technical and financial criteria for solicitation as per the schedule below:
- * Technical criteria weight: 70%
- * Financial criteria weight: 30%

Only candidates obtaining a minimum of 49 points (70%) in the technical evaluation shall be considered for the financial evaluation.

Of those offers considered in the financial evaluation, the lowest price offer will receive 30 points. The other offers will receive points in relation to the lowest offer, based on the following formula: (Pn / Pl)* 30 where Pn is the financial offer being evaluated and Pl is the lowest financial offer received.
