Agenda Item 1: Annual Project Progress Report (2016)

Issues:

- o The key strategic objectives of the project in 2016 were:
 - 1. Increase access to justice through coordinated institutional presence at state and county
 - 2. Support clearance of case backlog and address prolonged and arbitrary detention;
 - 3. Support harmonization of traditional justice with the formal justice sector; and
 - 4. Improve capacity development and institutional strengthening.
- The total budget for 2016 was US\$ 6,295,532 and expenditure US\$ 5,249,374.04 representing 83% delivery.

Key achievements:

- 769 (289 female) people received legal counsel or legal representation in the courts. 1617 (838 female) people in six states benefited from legal awareness raising activities conducted by UNDP-supported JCCs.
- 221 (58 female) police and 170 (100 female) social workers were trained in SGBV survivor-centric referral response.
- 1,037 (52%), including 76 SGBV, calls for emergency response responded to through UNDPsupported Emergency Call Centre in Juba
- 133 (31 female) police personnel and 163 (41 female) were trained in community policing and the concept of PCRCs.
- 5 ascertainment studies and 1 study on Harmonisation of Customary Laws and the National Legal System completed.
- Support to the MoJ in establishing a Technical Committee to conduct national consultations for the legal framework of the Commission on Truth Reconciliation and Healing (CTRH).
- 20 rule of law outreach activities to 495 (129 females) participants and 31 community policing outreach activities to 3,107 (1,103 female) community members.

Agenda Item 2: 2017 Annual Work Plan (AWP)

Issues:

As the Netherlands' funding on which the 2014-2016 AWPs are based is coming to an end, the project has developed a new project document, with new articulation of outputs and activity results. The 2017 AWP is based on this new structure.

New structure:

Output 1: Functions and capacity of rule of law institutions enabled to deliver accountable, effective and equitable justice services.

Activity results:

- 1.1 Key legislation to strengthen core functions of the rule of law sector is supported, with particular attention to human and women's rights issues.
- 1.2 Mobile court system established to reduce case backlog and arbitrary detention.
- 1.3 National prisons service supported to uphold the standard minimum rules for the treatment of prisoners.
- 1.4 Unified case management system established through coordination between rule of law institutions for timely processing of cases and reduction of case backlog.
- 1.5 Communities empowered and security sector institutions enabled for increased citizen safety.

Output 2: Measures in place and implemented in the rule of law and health sectors to prevent and respond to sexual and gender-based violence.

Activity results:

- 2.1: Coordinate and expand the provision of legal aid services to vulnerable groups.
- 2.2: Strengthen SGBV referral paths for vulnerable people to increase protection and opportunities for legal redress.
- 2.3: Improve livelihood skills for SGBV survivors.

Output 3: Capacity of state-mandated institutions and civil society strengthened to promote and protect human rights.

Activity results:

- 3.1: Strengthen the ability of the South Sudan Human Rights Commission to monitor and investigate human rights grievances.
- 3.2: Support the establishment of transitional justice, peace and reconciliation mechanisms in accordance with Peace Agreement and informed by international standards.

Financial status

The projected AWP budget for 2017 is US\$ 8,472,403 of which US\$8,134,036 is available.

Human resources

Recruitment of UNVs to replace outgoing colleagues who have reached the 4 year maximum is ongoing. Recruitment of a programme finance specialist to replace outgoing project finance specialist and P4 Police and Corrections Specialist to replace outgoing P5 CTA and P3 Capacity Building Specialist are ongoing.
