ANNEX B. FULLY-COSTED EVALUATION PLAN - TRINIDAD AND TOBAGO 2022-2026

The Multi-Country Office recognizes the importance of monitoring and evaluation in programme management. In its attempt to assess programmatic effectiveness the MCO has developed an evaluation plan for the period 2022-2026, focusing on the MSDF areas of i) "*Equality and Well-being*" and ii) "*Resilience to Climate Change and Sustainable Resource Management*". The choice of evaluations to be conducted within the period were chosen based on relevance to the attainment of Country Programme Document (CPD) outcomes, available funding, and whether the projects fell within the criteria for mandatory evaluations. It should be noted that the list of planned evaluations as presented below will not be limited to those identified in plan. The MCO will reserve the right to append additional evaluations to the plan over the course of the CPD period if other evaluations arise due to pipeline projects coming to fruition. As an NCC Country Office with limited dedicated resources available for the purpose of monitoring and evaluation, the MCO has decided, at this time, to omit from the evaluation plan any thematic or outcome evaluations. However, the MCO will reconsider this decision if over the course of the 2022-2026 programmatic period funding sources become available that would allow for a comprehensive outcome evaluation.
